

BOROONDARA EXPRESS RESERVES PLAYER CONTRACT 2024

THIS AGREEMENT is made no later than the 17TH day of November 2023.

BETWEEN "The Player" AND BOROONDARA NETBALL ASSOCIATION (hereinafter referred to as "BNA")

WHEREAS:

- 1. BNA is the managing body of the Boroondara EXPRESS VNL Netball Teams (hereinafter referred to as "EXPRESS")
- 2. The Player has presented herself for selection in the VNL teams of the BNA to play in the 2024 VNL Season.
- 3. The Player has been selected in the 2024 EXPRESS RESERVES SQUAD. This includes VNL Training Partners

AND IT IS HEREBY AGREED BETWEEN THE PARTIES AS FOLLOWS:

1. Duration

This Contract shall commence at the date of signing and shall remain in force for the duration of the 2024 VNL Season unless legitimately terminated by either the Player or the Association under the terms of this Agreement.

2. Player Commitment

2.1 By agreeing to this Contract the Player accepts the position offered to her by the Association to play for EXPRESS RESERVES Squad for the 2024 VNL Season.

2.2 The Player acknowledges that she has been advised that the following requirements are requirements of the position she has accepted and agrees that she will fulfill these requirements for the duration of the season:

- 2.2.1 To attend such training and match sessions as are reasonably directed by the Head Coach, commencing with the Pre-season program in November 2023.
- 2.2.2 To complete such home training as is reasonably directed by the Strength & Conditioning Coach;
- 2.2.3 To participate in fundraising and promotional activities as directed by the Boroondara Netball Association
- 2.2.4 To comply with sponsorship requirements as directed by Boroondara EXPRESS's managing body, BNA.
- 2.2.5 To adhere to communication pathways and dispute resolution procedures as directed by managing body, BNA.
- 2.2.6 To abide by the Netball Victoria Code of Conduct and the Netball Australia Member Protection Policy
- 2.2.7 To use social media in a manner consistent with the Netball Australia Member Protection Policy
- 2.2.8 To complete the Netball Australia Integrity Framework requirements prior to Round 1 of the 2023 season.

3. Fees

- 3.1 The Player shall be required to pay an acceptance fee for the 2024 season as assessed by the Association.
- 3.2 Should fees remain unpaid at the date nominated by the Association as the closing date, the Player will not be registered to play for Boroondara EXPRESS.

4. State Membership

- 4.1 The player is required to have 2024 Netball Victoria State Membership
- 4.2 The player is required to register on Netball Connect with <u>both</u> Parkville and VNL competitions.

5. Uniforms

- 5.1 The official Boroondara EXPRESS uniform must be worn to all matches and relevant activities, to comply with sponsorship requirements as per clause 2.2.4.
- 5.2 The Association shall supply uniform according to sponsorship arrangements with OnTrack Sportswear = dress and shirt
- 5.2 EXPRESS Reserves Players are required to purchase (minimum) tracksuit jacket & pants (or wear your own navy pants).

6. Gym Membership

The Association shall supply 12 months free gym membership according to sponsorship arrangements with Anytime Fitness (Kew)

7. Termination of Contract

Either the Player or the Association shall be able to terminate the Contract any time during the 2023 season by giving written notice to the other.
